WOODLAND HILLS, CA – Sept. xx, 2019 – A 20,557-square-foot office building at 22141 Ventura Blvd. in the Woodland Hills submarket of Los Angeles has traded to an owner-user for \$5,872,500, according to Scott Romick and Jay Rubin of Lee & Associates-LA North/Ventura, who represented the seller in the transaction.

The property, a three-story building constructed in 1987, features private balconies, a highly improved lobby and newer roof. It is located very close to the Ventura (101) Freeway and walking distance to numerous amenities.

Median sale prices for office buildings in the Los Angeles North region rose nearly 8 percent year-over-year as of the second quarter of 2019.
